

Scholarship Awards for the 2026 intakes of the Master of Global Business (MGB) and Master of Artificial Intelligence in Business (MAIB) programs.

In recognition of the outstanding academic achievements and leadership potential consistently demonstrated by FTU students in previous cohorts, SP Jain Global is pleased to offer eight (8) “Merit and Diversity Scholarship” Awards, covering up to 90% of net tuition fees, exclusively for FTU final-year and graduating students applying to the 2026 intakes of the MGB and MAIB programs.

The Merit and Diversity Scholarships recognise candidates who exhibit academic excellence, an international mindset, personal motivation, and a strong fit for the chosen program.

Each selected recipient will receive a financial award of up to USD 27,000 (for MGB) or up to AUD 42,200 (for MAIB – Sydney), subject to successful completion of the admissions process.

1. Eligibility: Final GPA: 3.5 or above (Students awaiting their final-year results may also apply. If selected, they will receive a conditional offer).

2. Statement of Purpose (SOP)

Applicants must submit a personal Statement of Purpose explaining why they wish to join their chosen program and how it aligns with their future aspirations (Only shortlisted candidates will be invited to complete the online application and proceed through the scholarship and admissions stages).

3. Scholarship & Admission Process

A. Online Application

- No application fee.
- The application link will be shared with shortlisted candidates.

Application deadlines:

- **Round 1:** February 27, 2026
- **Final Round:** March 10, 2026

B. Required Documents

- Updated CV or résumé
- Academic transcripts and degree certificate
- Passport copy (if available)
- English proficiency certificate

- Any other awards or certificates that showcase their profile

C. Scholarship Assessment Test (SPJAT)

All applicants will be invited to sit for the Scholarship Test(SPJAT) and complete an evaluation consisting of a short case study; business creativity assessment and a brief (100-word) essay(Applicants will receive detailed instructions and access to sample and mock test papers before the test. Candidates may also be invited to retake the test if required).

D. Evaluation & Interview

Shortlisted applicants will be invited to a virtual interview with SP Jain Global faculty (The interview and evaluation fee will be waived for FTU applicants. Applicants must be available on the pre-scheduled interview dates communicated at the time of application).

E. Admission & Scholarship Offer

Successful candidates will receive their final admission and scholarship outcomes by March 31, 2026.

4. English Language Requirements

MGB: IELTS (Academic) 6.5+, PTE 60+, or Duolingo 95+

MAIB (Sydney): IELTS (Academic) 6.5+ or PTE 60+

(Applicants may submit an updated English proficiency certificate before the start of the program if their current certificate expires).

The MGB program is designed to develop adaptive, globally minded leaders, equipping students with the skills to navigate diverse business environments, cultures, and markets. This 16-month full-time master's degree offers study across our campuses in Singapore and Dubai, an optional exchange term in London, and a four-month internship facilitated by our Corporate Relations Department.

The MAIB program is a unique interdisciplinary degree that will cover the foundations, principles, and techniques of artificial intelligence, as well as business subjects such as economics, accounting, finance, and marketing. This 24-month full-time master's degree offers study in Sydney, Australia where students can apply for post study work rights (Subclass 485) after completion of the degree.
